- 1. Introduction
- 1.2. The privacy of our website users is of great importance to us, and we make every effort to ensure that it is protected. This policy explains how we use your personal information.
- 1.3. By agreeing to the use of cookies on your first visit to our website, in accordance with the provisions of this Policy, you grant us permission to use cookies on each of your subsequent visits.
- 2. Collection of personal data

The following types of personal data are subject to collection, storage and use:

- Information about your visits to and use of this website, including referral sources, length of visits, pages viewed, and site navigation paths;
- Information about your email address that you used to register on our website;
- The information you entered when you created your profile on our website for example, your first name, last name, mobile phone number, and the image in your profile,
- Information such as your name and email address that you provided when you subscribed to our mailings and/or newsletters;
- Information you enter when using the services of our website;
- Information generated by the use of our website, including information about the time, frequency and conditions of its use;
- Information regarding any purchases, services used, or transactions you have made through our website, including your name, address, phone number, email address, and credit card information;
- Information you post on our site for the purpose of publishing it online, including your username, profile picture, and the content of your post;
- Information contained in any communications you send to us by email or through our website, including the content of the communication and the purpose of communication;
- Any other personal information you have sent to us.
 - 3. Use of your personal information

The personal information you provide to us through our website will be used for the purposes specified in these rules or on the relevant pages of the website. We may use your personal information for the following purposes:

- administering our website and business;
- personalizing our website for you;

- to enable you to use the services available on our website;
- sending you goods purchased through our website;
- providing you with services purchased through our website;
- sending you notices, invoices and payment reminders, and receiving payments from you;
- sending you emails that you have specifically requested;
- sending you email newsletters, if you have ordered them (you can notify us at any time that you no longer wish to receive email newsletters from us);
- sending you marketing communications about our business activities or the business activities of carefully selected third parties that we believe may be of interest to you, through publications or, if you have specifically consented to this, by sending you email or through the use of similar technologies (you may notify us at any time that you no longer wish to receive marketing communications);
- providing third-party companies with statistical information about our users (however, these third-party companies will not be able to identify any individual user from this data);
- handling inquiries and complaints made by you or about you that relate to our website;
- to ensure the security of our website and prevent fraud;
- to verify compliance with the terms and conditions governing the use of our website (including monitoring private messages sent through our website's private messaging service); and for other purposes.

If you have provided personal information for publication on our website, we will publish it., we will use this information in accordance with the license you have granted us.

4. Disclosure of personal information

We reserve the right to disclose your personal information to any of our employees, officers, partners, insurers, professional advisors, agents, suppliers or subcontractors to the extent and for the purposes set forth in this policy.

We reserve the right to disclose your personal information to any member of our group of companies to the extent and for the purposes set forth in this policy.

We reserve the right to disclose your personal information:

- in cases where the law requires us to do so;
- in connection with any current or future legal proceedings;
- to establish, exercise or defend our legal rights (including providing information to other parties for the purpose of preventing fraud or reducing credit risks);
- to the buyer (or potential buyer) of any business or assets we sell (or intend to sell);

- and to any person who we reasonably believe may request a court or other authorized body to disclose such personal data and, in our reasonable opinion, such court or authorized body will order the disclosure of such personal data.
- We will not disclose your personal information to third parties, except as specified in this policy.

5. Preservation of personal information

Section D sets forth the Company's policies and procedures for the retention of personal information. These policies and procedures are designed to ensure that we comply with our legal obligations to retain and delete personal information.

Personal information that we process for a specific purpose or purposes should not be stored for longer than is necessary to achieve that purpose or purposes.

6. Protection of your personal information

Our website is hosted by Wix.com. Wix.com provides us with an online platform that allows us to sell products and services. Your data may be stored in Wix.com's data warehouse, databases, and general Wix.com applications. They store your data on secure servers with a firewall.

7. Payment methods

9. Your rights

We reserve the right to refuse to provide information at your request, within the limits of the applicable law.

You have the right to instruct us not to process your personal information for marketing purposes.

In practice, you will usually either agree in advance to our use of your personal information for marketing purposes or we will provide you with the opportunity to opt-out of our use of your information for marketing purposes.

10. Update information

11. Cookies

Our website uses cookies. A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and stored by the browser. Subsequently, the identifier is sent back to the server each time the browser requests a web page from the server. Cookies can be either

"persistent" or "session": persistent cookies will be stored by the browser and will be valid until the expiration date, unless deleted by the user in advance;

"Session" cookies, on the contrary, will be deleted after the end of the session with the site or after closing the browser. Cookies usually do not contain any personally identifiable information. However, the personal information we hold about you may be linked to information stored and obtained from cookies.
